
Personal Opinion: I am not a doctor, but I am a mom who deeply cares about my children. I admit I would not vaccinate my children today. Why?

#### **Full Vaccine Schedule Never Tested**

The CDC schedule has never been tested as it is given to our children. This means we have no scientific basis for declaring this schedule "safe" & little understanding of the synergystic effects of 55 adjuvants, 234 antigens including 18 live viruses, human & animal DNA & viral contaminants, & antibiotics on the health of our children. While often considered modern medical miracles, vaccines are **invasive**, **irreversible medical procedures with known risks** (4, 5). It is these risks and the resulting litigious actions that prompted pharmaceutical companies to lobby Congress for legal immunity, without which they threatened to cease all vaccine production.

This resulted in the passing of The National Childhood Vaccine Injury Act of 1986

#### THE NATIONAL CHILDHOOD VACCINE INJURY ACT

This law freed vaccine manufacturers from ALL liability when injury or death following vaccination occurs. As a consequence, vaccine makers have zero incentive to make their products safe or effective since they are shielded from liability.

"No vaccine manufacturer shall be liable in a civil action for damages arising from a vaccine-related injury or death."

42 U.S. Code§ 300aa-22- Standards of Responsibility

This act set up the now controversial & bureaucratic Vaccine Injury Compensation Program in an attempt to offer recourse to those affected by vaccine injury and death. This program established a no-fault "vaccine court" that was intended to be a quick & easy way for victims to receive compensation funded by an excise tax collected on every vaccine dose produced. Instead, what has resulted is a lengthy, burdensome, contentious process in which victims of vaccine injury are treated with contempt & disrespect (6). The majority of cases are dismissed. The ones that are not dismissed receive nominal compensation that does little to cover the costs associated with caring for the injured. Even so, as of January 1, 2024, the Program has awarded \$5,134,788,935.74 in payouts since its creation (7).

#### No other product in this country is essentially mandated without consumer protections.



We now rank 35<sup>th</sup> in overall health outcomes—just behind Costa Rica, making the U.S., by most measures, including infant mortality, the sickest in the developed world. In addition to those 400 chronic diseases and injuries that FDA suspects may be vaccine related, the vaccine generation suffers unprecedented levels of anxiety and depression and behavioral disorders running the gamut from aggression to anorexia. Peer-reviewed animal and human studies have linked all these symptoms to vaccines.




At the 2mo, 4mo, and 6mo "WELL BABY" appointments,

These levels are considered unsafe and toxic for a 350lb adult.




#### Mawson Study

This study surveyed homeschool families in which the vaccination status of their children varied from unvaccinated to fully vaccinated. Thus, it controlled for genetics and environment. However, the detailed vaccination status of each "vaccinated" participant is unknown, so it is difficult to know how and if different vaccination schedules (e.g. the CDC schedule vs. a modified schedule) might affect autism risk. This study showed an enormous correlation between vaccination and allergy (3000% or 30X) and a very strong correlation between vaccination and neurological dysfunction, including autism (420% or 4 2X)








#### HISTORY OF VACCINES


Historically, vaccines were not as important to the decline of deaths from infectious disease as people think. Many of the diseases that plagued the U.S. in think. Many of the the early 1900s were declining in number before the vaccines to prevent them were even developed. This trend was likely due to factors such as better sanitation cleaner water, and better health care.

Even though the death rate for most diseases plummeted during the first half of the 20th century, fear continued and led to the development of vaccines. During the 1950s and 1960s, vaccines were developed for polio, diphtheria, pertussis (whooping cough), tetanus, measles, mumps and rubella. This list of recommended vaccines remained fairly unchanged from the 1960s to the 1980s. During those decades, pharmaceutical companies had to weigh vaccine profits against potential losses from vaccine injury lawsuits. That all changed with the 1986 vaccine act.





Vaccines are the only product in this country that are mandated for children without normal consumer protections.

#### THE NATIONAL CHILDHOOD **VACCINE ACT OF 1986.**

In the 1980s, pharmaceutical companies began lobbying Congress for legal immunity from vaccine injury claims, which were making vaccines unprofitable. In response, Congress declared that vaccines were "unavoidably unsafe," and passed the National Childhood Vaccine Injury Act to shield vaccine makers from liability. This Act also created the Vaccine Adverse Event Reporting System (VAERS) and the National Vaccine Injury Compensation Program (VICP).

It is estimated that less than 1% of vaccine injuries an deaths are ever reported to VAERS. In addition, the monetary compensation in the VICP "vaccine court" is limited to relatively nominal amounts. Still, the VICP has paid out almost \$5 billion since inception. These injury awards are funded through tax collecte on every vaccine dose, hence they are funded by the American people rather than the vaccine manufacturers.

A vaccine contains much more than the deactivated or dead virus for the disease that the vaccine is intended to prevent. There is a "cocktail" of other ingredients which serve as preservatives, adjuvants or cell culture material. Manufacturers discovered early on that the dead virus by itself did not activate the immune system enough to confer immunity, so they added "adjuvants Adjuvants are substances like mercury and aluminum which are toxic to the body and are used to "ramp up" the immune response.








Prior to the year 2000, mercury was used as an adjuvant and/or preservative in most vaccines. Around that time, concerns arose about the toxicity of mercury, so it was removed from all vaccines except the multi-dose flu shot.

Most vaccines now use aluminum as an adjuvant neurotoxin and questions remain as to how much is truly safe. A recent study found that a median weight baby receiving vaccinations according to the CDC schedule is over the "safe" aluminum limit 70% of the days in its first seven months. This study stated, "We cannot stress how important it is that infants avoid aluminum from all sources, at all doses, due to the realities of cumulative risk from cumulative exposure. Selecting brands of vaccines that contain lower amounts of aluminum and avoiding the combination vaccines that have the greatest amounts of aluminum would be advisable for reducing toxicity."



A study reported by the National Institute of Health found significant correlation between the number of vaccines and the infant mortality rates of countries. #### **HEP B FOR NEWBORNS**

Hepatitis B is a disease acquired via sexual contact or needle sharing with an infected person. It can also be passed from an infected mother to her baby at birth. Only a very small percentage of mothers are infected and it's easy to diagnose with a simple screening. Despite this fact, the Hep B vaccine is routinely given to ALL babies on the day of birth.

One danger with this vaccine is that the dose is not adjusted for the baby's weight – it is the same amount given to older children. While the aluminum in this vaccine is under the toxic limit for an adolescent, it is up to 17 times the limit for a baby, depending on its weight.
